Sheriff Sales in Philadelphia Postponed

Homeowners that were scheduled for sheriff sale on April 7, 2020 due to mortgage delinquency, received a sheriff sale postponement to June 2, 2020. Conciliation Conferences Rescheduled

Mortgage Foreclosure Diversion Program in City Hall Courtroom 676 conciliation conferences for March 19, March 26, and April 2 were suspended. Homeowners that were scheduled for those dates will receive another conciliation conference.

All other mortgage foreclosure hearings, conferences, and trials scheduled before April 1st are cancelled or postponed.

STRUGGLING TO MAKE PAYMENTS FOR UTILITIES?

PECO, PGW and PWD have postponed all shut offs until May 1, 2020. Late fees will also be waived during this period. PWD will restore services that have already been terminated for delinquent customers. Restoration fees are waived. Contact PWD at 215-685-6300.

Fannie Mae and Freddie Mac Mortgage Foreclosures Suspended Until May 17, 2020

As of March 17th, Federal Government stated foreclosures on Fannie Mae and Freddie Mac owned mortgages will be suspended until May 17th. Find out if your loan is owned by one of them by using the loan look up links below.

If your mortgage is owned by either one, you must contact your mortgage company to start the process.

FORECLOSURES HALTED ON FHA MORTGAGES

As of March 18th, the federal government announced that it would direct all mortgage servicers to halt all new foreclosure actions and suspend all foreclosure activities in process for FHA-insured mortgages. Contact your mortgage company to determine the status of your file.

Pennsylvania Housing Financing Agency (PHFA) Halts Foreclosures on Mortgages

On March 18th, PHFA has suspended all foreclosure actions for borrowers that are delinquent. PHFA will also stop all negative credit reporting for borrowers that are behind on mortgage payments.
